Suggested Admission Guidelines for Acceptance into the CNUSD Hybrid Online School are as follows:

- Minimum GPA of 2.00 in CORE Academic Classes.
- At or Near Standard scores on SBAC State Testing in English/Language Arts and Math.
- In addition, such factors as motivation, attendance, discipline, maturity level, academic potential, and interest level will be considered in the selection process.

In addition to completing the application, candidates who do not meet the minimum Suggested Admission Guidelines (GPA and test score criteria) may be asked to submit teacher/counselor recommendations and to interview with an administrator.

The administrator will carefully consider the student's interview along with teacher/counselor recommendations to determine if special circumstances exist which warrant special consideration for admission into the program. Students with special needs (English Learners, Special Education Students, 504 Plans, etc.) will be considered for admission based on their ability to be successful in a hybrid – online learning environment. (*A current copy of IEP and/or 504 Plans must be included with application.*)
